#### Office of the Coroner:

With recommendation from Coroner Patricia Felix, and after review by Solicitor Molly R. Mudd, Mr. Qually moved, seconded by Mr. Martin, that the Board of Commissioners approve the following:

- Designate Chairman Randy L. Phiel to approve the invoice from Hopkins Software Solutions, of Commodore, PA, for renewal of the Coroner's H.A.N.D. Notify Access. This software provides notification of Hospice and nursing home deaths directly to the Coroner's office. It is further recommended that the Board sign the Addendum to the End User Licensing Agreement, which incorporates the County's standard terms and conditions into the Agreement. The term of the Agreement is one (1) year, commencing on April 3, 2023 and terminating on April 2, 2024. Total cost to the County is \$350.00.
- Ratify the signature of Coroner Patricia Felix, dated September 26, 2022, on the Work Statement from the Pennsylvania Department of Health Prescription Drug Monitoring Program ("PDMP"). This Agreement provides that the Coroner's office will submit coroner reports and toxicology reports for overdose deaths, violent deaths, and maternal deaths in Adams County to the PDMP for purposes of monitoring and mitigation. In return, PDMP shall pay to Adams County \$10,000.00 for the submission of reports dating July 1, 2022 to June 30, 2023.

## **IT Department:**

Mudd, Mr. Martin moved, seconded by Mr. Qually, that the Board of Commissioners ratify the signature and approval by Chairman Randy L. Cleaning of these areas is necessary due to accumulation of debris from the welding which was performed on the HSB roof. It is further recommended that the Board sign the Addendum to the Services Agreement, which incorporates the County's standard terms and conditions into the Agreement. The term of the Agreement is one (1) year, commencing April 24, 2023 and terminating April 23, 2024. Total cost to the County is \$10,613.96.

 Designate Chairman Randy L. Phiel to sign the Estimate from On the Fly Pest Solutions, Inc., a Maryland Company, for pest control services at the ACACC. It is further recommended that the Board sign the Terms and Conditions between On the Fly and the County. The term of the Agreement is one (1) year, commencing March 22, 2023 and terminating March 21, 2024. Total cost to the County is \$3,393.72.

At this time Sherri Clayton-Williams, Director of Planning, was recognized and presented to the Board of Commissioners fourteen (14) proposed grant awards for their approval and funding through the County's American Rescue Act (ARRF) Grant program. Ms. Clayton-Williams thanked the review team, which was comprised of numerous members of county staff from various departments along with the consultant on this project GMA Funding Solutions. This review project included follow-up with the applicants which allowed the review team to make informed and careful consideration in offering these recommendations. She noted there were 43 applications submitted with requests totally \$25,901,961.71. The recommended projects all have a substantial impact to the community and meets the intent of the American Rescue Act and are classified under one of the following categories: Behavioral Health, Education, Housing, Infrastructure to support Economic Development, Public Health and Safety and Public Service.
