Phiel to sign on behalf of the Board the following Agreements with Microsoft Corporation and CDW Government, LLC, ("CDW-G"), an authorized reseller of Microsoft products, made pursuant to a Master Pricing Agreement executed by the County Commissioners Association of Pennsylvania (CCAP) on September 23, 2020:
  - ➤ Microsoft Enterprise Update Statement verifying that there has been no increase in the number of required licenses for our Microsoft enrollment this year.
  - Microsoft Enterprise Update Statement verifying that there has been no increase in the number of required licenses for our SQL/Azure Server Enterprise enrollment this year.

- Appoint Chairman Randy L. Phiel to sign on behalf of the Board the following Agreements with CDW Government, LLC, ("CDW-G"), an authorized reseller of Microsoft products, made pursuant to a Master Pricing Agreement executed by the County Commissioners Association of Pennsylvania (CCAP) on September 23, 2020, for the third year of payments in a three-year term:
  - ➤ CDW-G SQL/Azure Server Enterprise Quote Renewal of SQL Server/Azure licenses at a quoted price of \$29,586.48 per year. Effective July 1, 2021 for a three-year term.
  - ➤ CDW-G Software Enterprise Quote Renewal of licenses for various Microsoft products (Office 365, Exchange, Windows, etc.) at a quoted price of \$182,061.45 per year. Effective July 1, 2021, for a three-year term.

- Veterans Real Property Tax Exemption, effective with the 2023-2024 School Taxes:
  - ➤ Parcel #30G16-0035D, located in Mt. Joy Township for the home on 3.16 acres
  - ➤ Parcel #12C11-0065, located in Franklin Township for the home on 1.18 acres
- Veterans Real Property Exemption Removed:
  - Remove the exemption and place back on the tax rolls Parcel #30H18-0021E, located in Mt. Joy Township, which no longer meets the requirements for exemption

### Planning and Development:

With recommendation from Sherri Clayton-Williams, Director and after review by Solicitor Molly R. Mudd, Mr. Martin moved, seconded by Mr. Qually, that the Board of Commissioners designate Chairman Randy L. Phiel to sign the Proposal from GeographIT, a Lancaster, PA company, for Professional GIS Support Services. It is further recommended that the Commissioners sign the Addendum to the Proposal, which incorporates the County's standard terms and conditions into the Agreement. The term of the Agreement began on January 1, 2023 and terminates on December 31, 2023. The County will be billed on a time and material basis, with a not-to-exceed amount of \$5,000.00.

## **Adams County Industrial Authority:**

With recommendation from Robin Fitzpatrick, President, and on behalf of the Board of Directors, Mr. Qually moved, seconded by Mr. Martin, to approve the appointment of Harry McKean to the Board of Directors, effective May 31, 2023. Mr. McKean is filling the vacancy created by the resignation of Mike Hanson.

### **District Attorney:**

With recommendation from District Attorney Brian Sinnett, and after review by Solicitor Molly R. Mudd, Mr. Martin moved seconded by Mr. Qually, that the Board of Commissioners approve the Project Modification Request for the 2022-24 STOP Violence

Against Women Grant #36055, Amendment #2, from the PA Commission on Crime and Delinquency (PCCD) for \$375,000.00 in federal funds. As the cost of the Consultant hired by the County was lower than budgeted, this modification allows for a reallocation of the excess funds to be used for awards for STOP officers and STOP events. This modification does not change the overall grant amount. The Modification is effective May 4, 2023.

### **Building and Maintenance:**

With recommendation from Larry Steinour, Director and after review by Solicitor Molly R. Mudd, Mr. Qually moved, seconded by Mr. Martin, that the Board of Commissioners designate Chairman Randy L. Phiel to sign the following:

- Proposal from McClure Company, of Harrisburg, PA, for the installation of a new chiller pump and VFD/starter panel at the Adams County Adult Correctional Complex. The pump and VFD were previously purchased by the County. It is further recommended that the Board sign the Addendum to the Terms and Conditions between the County and McClure, which incorporates the County's standard terms and conditions into the Agreement. The quote is effective June 7, 2023. Total cost to the County is \$5,766.00.
- Quote from LowV Systems, Inc., of Mechanicsburg, PA, for the purchase and installation of three (3) new access control doors. This project is part of the remodel for the move of the Voter Registration Office to the Department of Emergency Services Building. This Quote is made pursuant to the terms of the Master Services Agreement between LowV and the County, signed on December 14, 2022. The Quote is effective on June 7, 2023. Total cost to the County is \$6,910.00.
- Memorandum of Understanding ("MOU") with The Theodore Burr Covered Bridge Society of Pennsylvania, Inc. ("Society"), a nonprofit organization dedicated to the preservation and restoration of covered bridges in Pennsylvania. This MOU provides for the painting of the historic Sachs Covered Bridge by the Society at no additional cost to the County. The Society will paint the outside of the bridge and apply flame retardant to the inside of the bridge. Work is anticipated to begin the first week of August 2023. The MOU is effective June 7, 2023.

## **Adams County Adult Correctional Complex:**

With recommendation from Warden Katy Hileman, and after review by Solicitor Molly R. Mudd, Mr. Martin moved, seconded by Mr. Qually, that the Board of Commissioners designate Chairman Randy L. Phiel to sign the Business Associate and Qualified Service Organization Agreement with PrimeCare Medical, Inc. of Harrisburg, PA, with whom the County contracts for the provision of medical services at the ACACC. The County as a Business Associate is required to enter into this Agreement with PrimeCare a Covered Entity pursuant to the Health Insurance Portability and Accountability Act of 1996 ("HIPAA "), and the Health Insurance Technology for Economic and Clinical Health Act ("HITECH Act"), as well as the regulations promulgated under the Acts (collectively, the HIPAA Rules"), the Federal Confidentiality Law, 42 USC §290dd-2, and underlying regulations at 42 CFR Part 2, and applicable state and local statutes and regulations. The Agreement is effective as of June 7, 2023.

## **Human Resources:**

With recommendation from Michele Miller, Director and after review by Solicitor Molly R. Mudd, Mr. Qually moved, seconded by Mr. Martin, that the Board of Commissioners designate Chairman Randy L. Phiel to sign the following Agreements with Capital BlueCross regarding the administration of employee health benefits in 2023:

- Administrative Services Only (ASO) Group Contract and Declaration Page An
  agreement for Capital BlueCross to administer certain health benefits on behalf of
  the County as described in the plans and benefits booklets outlined herein.
- Group Preferred Provider Benefits General benefits, coverage, and administrative
  procedures under the PPO Plans for union and non-union employees. For 2023, the
  Benefits Booklets have been modified to include a \$500/\$1,000 base level deductible
  for all groups except for Teamsters Support, which will remain at a \$250/\$500 base
  level deductible.
- Rx Card Plan Prescription drug benefits and coverage under the Plan. For 2023, the
  prescription plan has added "90DayMyWay" to allow employees to obtain
  maintenance drugs in 90-day supply.
- Vision Benefits Vision plan benefits remain unchanged from 2022.

All agreements are effective January 1, 2023, for a term of one (1) year, ending December 31, 2023.

Mr. Martin moved, seconded by Mr. Qually, to approve and sign the Engagement
Letter with PFM Financial Advisors, LLC, a Financial Advisory Firm based in
Harrisburg. This Engagement Letter outlines the scope of financial advisory services
that PFM will offer to the County related to financial planning, budget, strategic
advice, policy development, and debt issuance. The cost of any service offered under
this Agreement will be negotiated by the parties at the time the service is
required. This Agreement is effective May 9, 2023 and shall continue until
terminated by either party.

 Mr. Martin moved, seconded by Mr. Qually, to designate Chairman Randy L. Phiel to sign on behalf of the Board of Commissioners, the Agreement with Contractor Jay Fulkroad & Sons, Inc. of McAlisterville for the Maintenance Repairs of Forty County Bridges, at a base bid price of \$489,628.19.
